- 1) The WTBOA reserves the right to withdraw any horse from the Summer Yearling and Mixed Sale which it does not consider to be of an adequate physical standard. In the event of such withdrawal, all entry fees, except the nomination fee, shall be refunded.
- 2) **SALES NOMINATIONS RECEIVED WITHOUT THE CORRECT FEE AND WHICH REMAIN UNPAID AT THE NOMINATION DEADLINE MAY BE SUBJECT TO WITHDRAWAL.**
- 3) The number of yearlings for this sale shall be determined by the quality of the entries and not mandated by available stable space controlled by the WTBOA.
- 4) Upon acceptance to the Summer Yearling and Mixed Sale, an entry fee of \$325 is due by June 5, 2015.
- 5) Commission for summer session yearlings is \$300, or 6 percent, whichever is greater.
- 6) For each yearling for which a commission is paid (sold or RNA) a \$50 fee will be deducted from consignor's proceeds in support of the WTBOA Sales Incentive Program. If a yearling passes through the ring as not sold, consignor will have the option to pay the additional \$50 fee to make each horse eligible.

The Emerald Bonus Program was made available to all 2014 WTBOA Summer Session yearlings (Hip Numbers 1-106) that went through the ring (sold or RNA) at the 2014 WTBOA sale (“Qualifying Horse”). Horses in the Mixed or Paddock Sessions of the Sale are not eligible for the bonus program.

Bonuses will be paid to Qualifying Horses who break their maiden at Emerald Downs. This one-time bonus will be for Qualifying Horses of any age and at any level. The chart at right lists the bonus that Owner(s) and Consignor(s), defined below, will split, 50% to the Owner and 50% to the Consignor, for each corresponding level at which the Qualifying Horse breaks its maiden. The bonus amount will not change, regardless of any change in the purse structure.

The Consignor is the Registered Owner(s) listed on the 2014 WTBOA Summer Sale Yearling Session Contract.

The Owner is the person who owns the Qualifying Horse at the time that it breaks its maiden.

Added Value for Your Sales Yearlings and Weanlings

Beginning in 2011, the WTBOA began a sales incentive program that benefits all WTBOA sales graduates. A **\$1,000 OWNER’S INCENTIVE BONUS** is available to every WTBOA-sold two-year-old graduate (sold or RNA as a weanling or yearling at a WTBOA sale) who breaks its maiden in a maiden optional claiming, \$30,000 and up maiden claiming, allowance or stakes race at Emerald Downs.

In addition, the WTBOA Sales Incentive Program will feature a **\$20,000 ALLOWANCE RACE**, to be run at Emerald Downs sometime in late summer, for two-year-old WTBOA sales graduates running at the Emerald Downs meeting. (Funds and/or horse population permitting, two separate \$20,000 races may be run – one for fillies and one for colts/geldings.)

A two-part process will fund the incentive program. First, consignors will automatically contribute a \$50 fee, which will be deducted from their proceeds, for each yearling or weanling (sold or RNA) in order to make the horse provisionally eligible for the incentive program. Buyers will then be offered the opportunity to support the program by paying an additional \$50 for each horse purchased, thereby completing the \$100 eligibility fee. Consignors of horses whose reserves are not attained (RNA) will also have the opportunity to make an additional \$50 payment, thus completing those yearlings’ eligibility for its two-year-old year.
